# CODE COMPLIANCE

Working with the Duluth community to maintain a safe and attractive place to live, work and play!

The Code Compliance Division within Duluth's Planning & Development Department maintains the City's status as a clean, livable city by ensuring that all properties comply with the standards set by the Unified Development Code and Municode. It is the City's policy to ensure compliance with the City's ordinances by investigating and resolving reported violations of City code. The City will work to assure compliance with property owners and by taking enforcement action, if necessary, against code violators who do not comply.

# **COMMON CODE VIOLATIONS**

#### **OVERGROWN VEGETATION**

Grass and vegetation must be maintained at a height not to exceed eight (8) inches. Noxious weeds are prohibited. All unpaved areas of front yards shall be maintained with grass,

ground cover, mulch, or similar landscaping material to prevent bare soil.

#### **FENCES/WALLS IN DISREPAIR**

Fences and walls must be maintained, structurally safe, and in good operable condition.

#### **PARKING IN RESIDENTIAL AREAS**

Parking is prohibited on grass or any other unpaved surface. No heavy truck, tractortrailer or panel truck shall enter, travel or park on the street in a residential subdivision or park on a right-of-way in the City of Duluth overnight. Business vehicles shall not have signs on them when parked on the premises and will not have any equipment used in the business attached.

# **TRASH AND RECYCLING BINS**

Residents that live within Duluth city limits are required to use Duluth City bags for trash services. Bags can be found at your local Publix and/or Kroger stores. Bags should be placed on the curb for pick-up

Trash and recycling bins cannot be placed at the curbside earlier than 6pm on the day before scheduled collection. Please remove bins from curbside promptly after pick up.

### JUNK VEHICLE STORAGE

lunked, wrecked and inoperable vehicles are not allowed to be stored on property, unless vehicle is stored in an enclosed structure. Vehicles stored outside of enclosure must be operable and have a valid license plate attached at all times.

#### **OPEN & OUTDOOR STORAGE**

The open or outdoor storage of any trash, building material, mattress, sofa, junk, debris, tires, boxes, containers, bins, appliances, or other materials is prohibited.





It is illegal for any person to throw, drain, or otherwise discharge into the city separate storm sewer system anything other than Stormwater. This includes liquids such as run off

from washing a vehicle and solids such as grass clippings and leaves.

## SIGNAGE

Temporary signage is restricted at all locations in the City of Duluth and only allowable by a temporary permit issued 110-573-2770 104-57 at City Hall. Under no circumstances shall signs be placed in the public right-of-way. Signs placed illegally will be confiscated.



• Demolition permits: Required for the demolition of any structure within City limits.

PRIVATE HOME

- Building permits: Required for all new construction and additions
- Fence permits: Required for all fences over 7' and fences in front yards
- Roof permits: Required for all new roofs and roof recovering

# HOME BASED BUSINESS

Home businesses are allowed in most residentially zoned areas of Duluth. A homebased Occupational Tax Certificate is required from the City for all home-based businesses.

# THE CODE COMPLIANCE PROCESS

Enforcement of all City Code and Ordinances usually begins with a written Notice of Violation provided to the owner and/or occupant. The notice shall be posted at the property or sent via mail. The notice shall contain a deadline of no more than thirty (30) days for compliance. If the violation continues past the deadline, the Compliance Officer may issue a citation for appearance in Duluth Municipal Court.
