This questionnaire has been developed to assist the City Administrator and the Mayor and Council in the review process of applications to determine applicant eligibility requirements and qualifications for Board/Commission membership.

- Will I attend the meetings regularly, making them a priority for the duration of my appointment?
- Am I willing to perform a reasonable amount of work outside of regularly scheduled Board or Commission meetings, and will I be prepared for each meeting?
- Am I committed to the goals of the City and other members of the Board or Commission, the City Administrator and Department Directors?

- What is my real motivation for accepting membership on the Board or Commission?
- Will I be there to help when controversy arises?
- Am I willing to participate in necessary Board/Commission training, education and development activities that will improve my effectiveness in my position?

Boards and Commission Information

Planning Commission

Five members and one alternate, all must be residents or business owners. Term is three years which begins on March 31st. Meet 1st & 3rd Monday each month @ 7:00 pm.

Zoning Board of Appeals

Five members and one alternate; all must be residents or business owners. One member must be on the Planning Commission. Term is three years which begins March 31st. Meet 4th Wed each month @ 7:00 pm.

Core Preservation District Review Board – Commercial (CPD-C)

Seven members, of which three members from CPD-R and four from DDA. One member from ZBA. Term is three years which begin in March. Meetings are as needed.

Core Preservation District Review Board – Residential (CPD-R)

Five members, of which three must be City residents. One member must be on the ZBA. Meetings are as needed. Terms are three years which begin in March.

Alcohol Review Board

Five members and two alternates who shall be nominated to M&C and undergo investigation. Members shall be city residents for a minimum of one year. One member may be business owner for a minimum of one year. See Duluth Code Sec 3-561 (d). Meetings are as needed. Terms are two years which begin in March.

Construction Board of Adjustments and Appeals

Five members with knowledge of construction codes/design. Meetings are as needed. Term is three years which begins in March.

Downtown Development Authority (DDA)

Seven members must be city residents or own/operate business located within the downtown area, or a member of the governing body. At least four must have economic interest in the downtown redevelopment. Meetings are second Tuesday of each month @ 6:30 pm. Term is four years beginning in March.

Parks and Recreation Advisory Board

Eight members plus one alternate, seven which must reside in City. Eighth may be resident or business owner. Term is two years and begins in March. Meetings are 1st Wednesday each month @ 7pm.

Finance Committee

Up to seven members: two members of the governing body, one, two or three city residents with investment experience. The City's Budget Financial Analyst and Human Resource Manager are automatically appointed. Term is two years and begins in March. Meetings are as needed.

Urban Redevelopment Authority

Three members, four year terms, who shall organize themselves and elect from one of their number a Chairperson, Vice Chairperson, a Secretary and a Treasurer. The Secretary and Treasurer may be but need not be a Commissioner. Annual meeting is in December/Meet as necessary.

Community Betterment Commission

Five members, one member from Planning Commission, one member from ZBA, one CPA, one Parks & Recreation Advisory Board, and one citizen at-large. Meetings in Spring and Fall or as necessary.

Municipal Court Judges

One Chief Judge and an unspecified number of Associate Judges who may be part-time, full-time or stand-by judges. Must be 21 years of age and a member of the State Bar of Georgia. Court currently held the first through fourth Thursdays of each month. Term is one year set by Charter.

Ethics Board

Ethics ordinance adopted by Council June 11, 2007. The Mayor and Council designate two qualified citizens each to provide a pool of twelve.
