Schedule Notes

¹ The filing deadline is met when a complete application is provided to the department of Planning & Development. Incomplete applications will not constitute fulfillment of this deadline.

² The resubmittal deadline constitutes the latest possible date at which revised plans and/or additional information and materials can be provided to the case manager in order for the case to proceed on the expected schedule track. Unfulfillment of this deadline will result in the case being moved to the next available schedule track.

³ The proof of notice deadline constitutes the point at which sufficient evidence must be given to the case manager showing that all notification requirements as set forth by the City of Duluth have been met. Unfulfillment of this deadline shall result in the case being moved to the next available schedule track.

⁴ The PC Hearing date column shows all regularly scheduled meetings of the Duluth Planning Commission for 2009. No case shall be heard at a meeting until the preceeding Filing, Resubmittal and Proof of Notice deadlines have been met in full.
