

WORKERS' COMPENSATION POLICY ACKNOWLEDGEMENT
City of Duluth

To: ALL CITY EMPLOYEES

Panel of Physicians: I understand that when I am involved in an on-the-job injury and emergency treatment is NOT necessary, that I must accept the services of a physician of my choosing from the Panel of Workers' Compensation Physicians. (If I desire to obtain medical services from a physician not listed on the Panel, I may do so, however, I will be totally liable for the cost of all medical services and will not be eligible for workers' compensation disability income benefits.) The physician selected from the Panel may arrange for appropriate consultations, referrals, and other specialized medical services, as the nature of the injury requires. If I am dissatisfied with the physician selected, I may make one change to a second physician also listed on the Panel upon notice to my employer. However, any further changes require the permission of the employer/insurer, self-insurer claims office, or the State Board of Workers' Compensation.

In the case of an emergency, I should be taken to the nearest emergency room. However, a physician from the Panel (or their referral) must thereafter, render all follow-up care.

Notification of Injury: I further understand that I must notify my supervisor and the City's Human Resource department as soon as possible following the injury, regardless of the extent of the injury. Delay in notification may result in denial of payment for medical services rendered.
